Water Operator Update (Lucas)

Clerk Update:

Marilyn has proposed one last letter to the property owner and operator of the plow that damaged a hydrant last winter. The plow operator has ignore the bills being sent and there was no response from the property owner to a letter sent last summer. Troy made a motion to send another letter and was seconded by Matt. The Board approved the sending of one last letter before deciding on a course of action to collect compensation for the repairs.

Communications:

Yellowstone Ecological has contacted Marilyn regarding their water bills. The Board stated that we need to follow standard procedures and let them know that if we turn water off , there is a significant hook-up fee to get it turned back on.

New Business:

The Cooke City Fire Dept has hired Marilyn to take over their bookkeeping. To save on cost, it has been suggested that the fire company's work could be done on the water district's equipment and pay a nominal annual fee for use of their laptop & software, printer and what few office supplies they would need. Troy made a motion to charge the fire district a \$100 annual maintenance fee for use of the water district's stuff, plus any other incidental expenses incurred, and was seconded by Rick. Motion passed.

Marilyn sent a reminder that there are 2 seats on the Board coming up for election this year. Kay and Matt will both run again for their seats on the Board.

With no further business to attend to, the meeting was adjourned at 7:30 pm.

The next meeting will be moved up to Thursday, March 14th @ 6:30pm at Antler Lodge so that Deb can attend.
